Sustainability Policy

The Addtech Group’s (Addtech) vision is to provide leading technical solutions for a sustainable tomorrow. To support our vision we have set clear long-term targets related to our three focus areas within sustainability.

By the year 2030, we are committed to:

To emphasize the importance of reducing our impact on the climate, Addtech has complementary climate reducing targets, approved by Science Based Target initiative.

To achieve our vision and targets as well as to develop our business overtime, all companies within Addtech should work in-line with this policy and integrate sustainability into the business and establish strong partnerships in the value chain.

Our main objective is to grow with sustainable profitability while minimizing negative impact along with maximizing positive impact on people, society and the planet. Our main objective will be reached by evaluating sustainability risks and opportunities on a regularly basis and by working systematically to mitigate risks, to develop opportunities and to aim towards our targets.

All communication including reporting is clear, transparent and distinct and interactions with our stakeholders are key.

Addtech shall always comply, at minimum, with applicable laws and regulations but the direction is towards best practice.

The Addtech Code of Conduct is the guideline of business ethics for all employees within Addtech and we shall always conduct business with a high degree of integrity. We inform and educate our employees to integrate sustainability perspective and aspects in daily operations within our companies.

The perspectives of sustainability are essential parameters when evaluating a company before an acquisition and are integrated in our due diligence process and our introduction for new companies.

The Addtech Supplier Code of Conduct should be known and set as the minimum level for all our suppliers. We strive for sustainable sourcing of all our products and solutions therefore we should continuously work to improve transparency, dialogue and collaboration in our supply chain.

People and Society

We are committed to be a positive force in the society where we are active and to provide good working conditions in our group as well as in our supply chain.

- Anyone who works directly or indirectly for Addtech shall be entitled to have their basic human rights respected.
- We do not permit discrimination or harassment in any form.
- Employees shall be given the same opportunities for development regardless of gender, age, ethnic origin, religion, political views, sexual orientation, disability or other distinguishing features.
- We ensure a good work environment from a physical, psychological and social point of view, and we strive to be an attractive employer.
- We always provide safe and healthy working environments and strive towards our zero vision of work-related accidents.
- We do not accept that employees are working under the effect of alcohol or drugs.
- We do not accept corruption, bribes or unfair anti-competitive practices. Procurement, sales and marketing of our products and services must be handled professionally and in line with relevant legislation and regulations.
- We comply with applicable anti-corruption legislation and regulations.
- We comply with the tax laws and tax rules of each country, where Addtech operates.
- Addtech works systematically towards good working conditions in the supply chain.
- All suppliers associated with high sustainability risks shall be evaluated and audited.

The Planet

We are committed to reduce our environmental footprint and our focus is to reduce emissions, protect the nature and biodiversity and sustainable use of resources.

- We should reduce our impact on the climate by efficient use of all energy (electricity, heating, cooling) and the energy should be based on renewable sources. We should work towards reducing the climate impact from production and use of our products and solutions. We should optimise transportation of goods, preferably based on electricity and renewable sources.
- All traveling should be evaluated from the perspective of emissions, business necessity, time efficiency and economy.
- We work towards reducing our own and our value chains negative impact on affected ecosystems and to avoid negative impact on biodiversity.
- We work to optimise our use of resources such as energy, fuel, raw materials, waste, water and land and to avoid use of hazardous chemicals in our own operations as well as work to impact our suppliers in the same direction.
- We work to minimise generation of waste by prioritizing reuse of material and secondly to have the ambition to send all waste to material recycling.
- We promote the transition towards a circular economy. In dialogue with suppliers we should work towards reducing use of virgin raw material and optimize design for material reuse/recycling at end of life for the products and solutions we provide to the market.
- We include environmental aspects early in our decision-making processes.

We expect and encourage our suppliers, subcontractors and all business partners to work in line with our sustainability policy and our Supplier Code of Conduct.

We strongly believe that the way forward, towards a more sustainable industry includes partnership and cooperation from a broad perspective.
